HCPCS Codes Requiring NDC on Claims

For Dates of Service: 7/1/2015 - 9/30/2015

As of September 1, 2012 Cigna requires the National Drug Code (NDC) number in addition to the Healthcare Common Procedure Coding System (HCPCS) code on certain claims, when the patient's health plan requires precertification. This requirement is in addition to the requirement to include NDC on claims for unclassified (unspecified) codes. For more information on the Unlisted Codes requirement, refer to the Cigna reimbursement policy R08 available on the secure Cigna for Health Care Professionals website (CignaforHCP.com > Resources > Clinical Reimbursement Policies and Payment Policies > Modifiers and Reimbursement Policies > R08 – Unlisted Codes).

Affected codes

There are three HCPCS specialty medication codes that are affected:

J0725 - Injection, chorionic gonadotropin, per 1,000 USP units

J1830 - Injection interferon beta-1b, 0.25 mg

J2941 - Injection, somatropin, 1 mg

We have provided a table listing the HCPCS codes and the corresponding NDC number for each. During claim processing, we will determine if the NDC on the claim matches the drug name approved during the precertification. If the NDC number does not match the drug name that was precertified, the claim may be denied in part or in full. If the NDC number is not included on the claim, we will send you a request to submit the NDC so that we may process your claim.

When to submit a NDC number

Submit the NDC number along with the HCPCS code on the claim when all of the following apply:

- The medication is administered to individuals covered by Cigna PHS+ plans (the plan requires precertification for outpatient services)
- The place of service is a physician office (11) or the patient's home (12)
- The Cigna administered plan is the primary payer

What to Include on the claim

Please follow these guidelines when including the NDC number on claims for the affected HCPCS codes:

- Include the HCPCS code
- Include the 11-digit NDC code (NDC quantity and unit of measure will be accepted but are not required at this time)
- For electronic claims, the place of service must be 11 (physician office) or 12 (home). Work with your vendor to include the NDC number in LIN segment of 2410. Also, Include the Current Procedural Terminology (CPT) codes in SV1 Segment of Loop 2400.
- When reporting NDC numbers on an electronic claim, it should be reported as 11 digits with no hyphens.
- On a paper HCFA-1500 form, include the NDC number in the shaded area of the service lines in field 24.
- When a claim is submitted with a HCPCS code requiring a NDC more than one time, each instance of the code must include the NDC.

An alternative to capturing the NDC

When you use Cigna Home Delivery Pharmacy, there is no need to capture the NDC number – all you need to do is submit a claim for the medication administration. By completing the appropriate Specialty Pharmacy prescription order fax form, you can request precertification and order the medication in one easy step. For your convenience, Cigna Home Delivery Pharmacy will:

- Verify patient eligibility
- Ship the medication directly to the destination of your choice by the needed date
- Capture the NDC number for you and bill Cigna directly for the cost of the medication
- Send education materials to the patient
- Coordinate refills

Information about the list

The HCPCS code applies to dates of service at any time between the effective date and the termination date. If termination date is blank, the NDC number is currently required to be on the claim for that HCPCS code.

The NDC codes listed on this document will be valid for use on Cigna claims for services rendered during the time period indicated at the top of the document, even if the NDC becomes obsolete during the indicated time period.
